**1. Introduction**

The board of directors of the Company (the "**Board**") refers to:

- (a) the scheme document (the "**Scheme Document**") despatched on 6 September 2016 to the shareholders of the Company ("**Shareholders**") in relation to the proposed acquisition by the Offeror, a wholly-owned subsidiary of Temasek Holdings (Private) Limited ("**Temasek**"), of all the issued and paid-up ordinary shares in the capital of the Company (other than those already held by Temasek) by way of a scheme of arrangement at a Scheme Price of S\$1.68 in cash for each Scheme Share under Section 210 of the Companies Act and in accordance with the Code and the terms and conditions of the Implementation Agreement; and
- (b) the announcement dated 25 October 2016 released by the Company in relation to the Effective Date of the Scheme.

All capitalised terms used and not defined herein shall have the same meanings given to them in the Scheme Document.

**2. Date for payment and delisting date**

The Board wishes to confirm that the Offeror has made payment of the Scheme Price on 27 October 2016.

The Board further wishes to announce that the Company will be delisted from the Official List of the SGX-ST with effect from 31 October 2016.

The Board takes this opportunity to thank all Shareholders for the continued support given to the Company since its initial public offering and listing.
