# Please specify details	<p>By virtue of a series of transactions by associated companies of Temasek (namely, the subsidiaries of DBS Group Holdings Limited ("DBSH")) and a subsidiary of Temasek (namely, Fullerton Fund Management Company Ltd ("FFMC")).</p> <p>As at 16 July 2010, Temasek therefore had a total interest in 835,373,203 ordinary shares representing 55.05% of the issued shares comprising:-</p> <p>(i) 824,400,030 shares owned by Temasek directly;</p> <p>(ii) 10,643,173 shares in which DBSH has an interest; and</p> <p>(iii) 330,000 shares in which FFMC (as discretionary investment manager) has a deemed interest.</p> <p>Temasek became aware of the change in percentage level of its interest in the shares on 20 July 2010.</p>
