

RIDE WITH SMRT TAXIS, PAY WITH MASTERCARD & ENJOY \$0 ADMIN FEE (“CAMPAIGN”)

TERMS & CONDITIONS

Campaign

1. A passenger who rides on an SMRT Taxis taxi and pays using MasterCard branded card (“**Passenger**”) will enjoy the following benefits:

Administration Fee (per trip)	Applicability
\$0	For MasterCard branded card transactions during the Campaign Period
\$0.30	For MasterCard branded card transactions after the Campaign Period

2. This Campaign will commence from 1 March 2017 and end on 31 December 2019 (“**Campaign Duration**”). SMRT Taxis may change, add, suspend, cancel, remove or otherwise modify the \$0 admin fee offered at any time without prior notice.

General

3. By participating in the Campaign (including the Roadshows and redemptions), each Passenger and non-Passenger participant (“**Participant**”) agrees to be bound by these terms and conditions (and all subsequent revisions thereafter made) or such other rules and regulations as imposed by SMRT Taxis. Each Participant shall submit to all decisions of SMRT Taxis which shall be final and binding on all matters relating to the Campaign.
4. SMRT Taxis reserves the right to postpone, suspend, cancel or limit the Campaign at its sole discretion at any time upon the occurrence of any events or circumstances beyond their control which hinder, prevent or affect (or may likely to have such effect) the Campaign including, without limitation acts of God, natural disasters or catastrophes, riots or wars (whether declared or not), terrorist activities, epidemics, health threats, quarantine requirements or any change or issuance of any applicable laws.
5. Each Participant acknowledges and agrees that photographs may be taken during the Campaign for use in promotional brochures, event publicity and other related purposes by SMRT Taxis and its related corporations. SMRT Taxis and its related corporations shall have the right to use pictures and photographs taken in relation to the Campaign.
6. To the extent permitted by law, each Participant agrees to release, discharge, indemnify and hold harmless SMRT Taxis or its related corporations (the “**Indemnified Parties**”) from any and all liabilities, claims, demands and/or damages of any nature whatsoever arising out of or relating to the Campaign, the prize(s)/ redemption item(s) and/or any activity relating thereto, including but not limited to any death, personal injury and/or property damage, any tax liabilities in relation to the prize(s)/ redemption item(s) insofar as not caused by the Indemnified Parties. In no event shall SMRT Taxis be liable for any special, direct or indirect and consequential losses and/or any other liabilities howsoever caused in relation to the Campaign.
7. The Campaign shall in all respects be governed by the laws of Singapore.
